Dogs may enter both the Instinct Test and Novice class in the same trial. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$55 fee for all returned checks.

#### **EXHIBITOR INFORMATION**

All dogs must be on a short leash and under control BEFORE, DURING AND AFTER TRIAL on Trial GROUNDS.

FLEXI LEASHES and EX-Pens ARE NOT PERMITTED INSIDE ANY BUILDINGS. Please pick up after your dog and dispose of waste in appropriate containers.

Please bring weather appropriate gear. These trials will be in the dog barn. It is insulated but not climate controlled. We have a 25' ceiling fan that does keep us cool and some propane heaters for warmth. Crating is limited indoors or out (you may bring canopies). There is no access to power so bring battery operated fans/heaters (or gas heaters) if you need them. Bring your own dog water. We have a VERY LARGE clean grass field for potty area. Quiet horse farm setting- PLEASE DRIVE SLOW (10mph). A Bathroom is on site.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. We will designate a BIS crating area.

If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing. Remember your dog must always wear panties WITH a liner at the show site. (except once she is IN her BIS potty area). We will direct you to your crating and potty area. Please come to the secretary's table before unloading your dog. Thank you!

Entry fees for bitches that come into season will be refunded until closing date of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. If a dog is injured or ill, you may be eligible for a partial refund. Please contact us for more info. A full refund will be given if we are notified before the closing date.

**AWARDS:** We will have placement ribbons in each class and height divisions. All qualifiers will be awarded a qualifying ribbon. We will have High in Class awards for each trial.

#### If you are expecting to earn a RATCH or above, please let us know.

Exhibitors are responsible for being ready to go to the staging area, in the staging area, and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class. The club has no obligation or responsibility for the purpose of calling or locating dogs that are not brought to the ring when required. Owners are responsible for errors in making out entry forms, whoever may have made such errors. Always check your confirmation email! Returned checks do not constitute a valid entry fee. There is a \$55 returned check fee.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so, WILL be fined and may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.

Food- On Fridays there are two local stores that serve meal. One mile toward Farmerville, THE CORNER STORE serves fish from 11-12. Five miles southeast, THE PARISH LINE MARKET, one can call in sandwich and salad order. All other food is over 10 miles away.

The Barn Hunt website has an awesome feature... it will create and fill out an entry form for

you. We encourage you to make use of this feature. (no errors because of hard to read entry forms!)

It isn't an online entry. It just creates your form and calculates your entry. You just print, sign and mail it!

1.) Go to barnhunt.com and Go to the <u>manage your dog</u> page, select the trial you wish to enter. (If the trial isn't open yet it will tell you the date it opens, if it is open, there will be a link that says create entry)

2.) Click Create Entry 3.) Select your dog <if you have more than one registered with Barn hunt>, then select the classes and trials, you wish to enter, at the bottom on the page there is a check box saying you understand you must print and mail the forms... CHECK that to make the print button functional. 4.) Click the print and it will create an entry form for each dog. Sign EACH one and mail ....there you go! (you MUST PRINT the actual entry form!) We strongly suggest you make use of this feature; it will make data entry much easier and ensures your results are recorded more quickly with Barn Hunt Association!
